
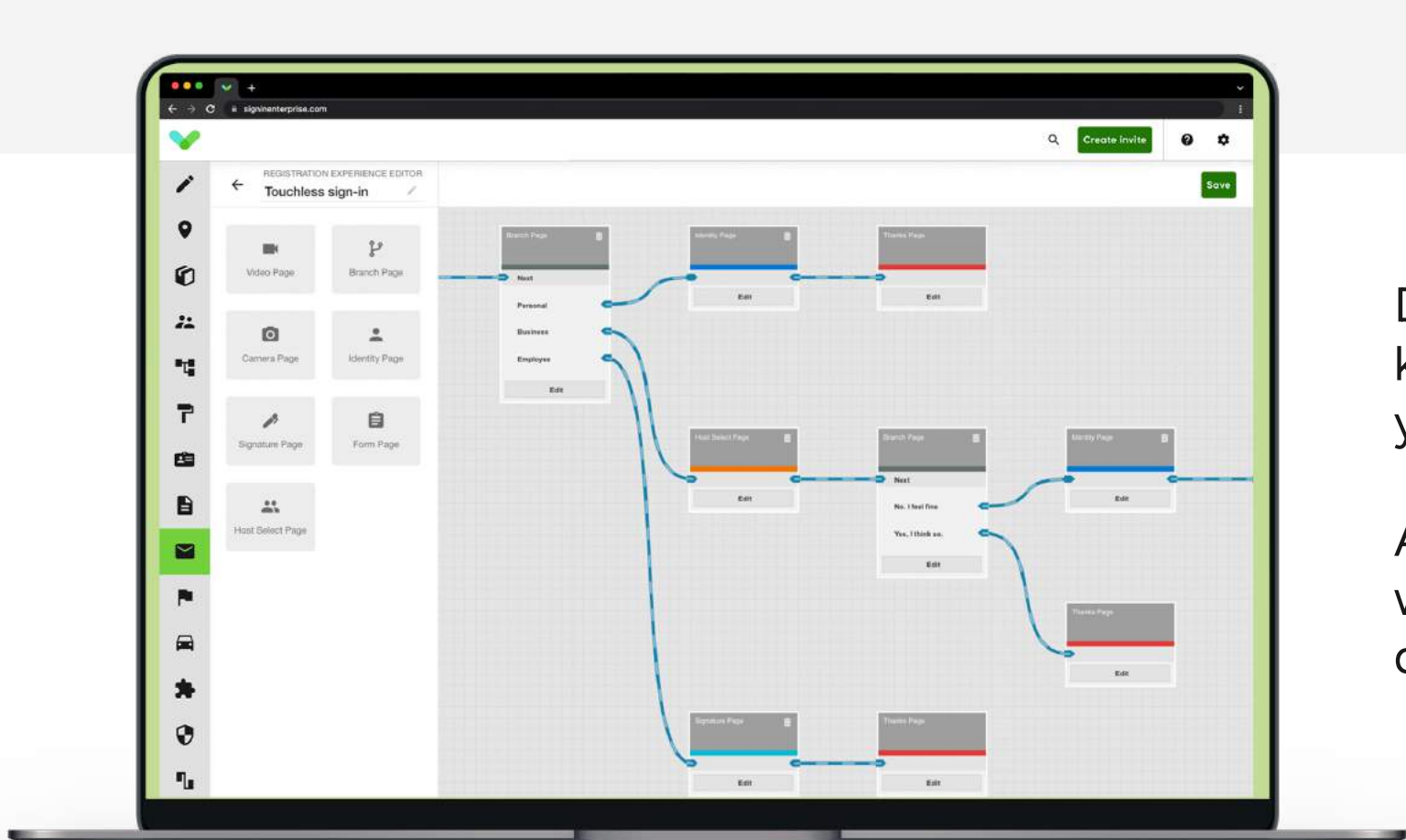

Scalability

- ☐ Can the solution configure to location, business unit, and office geography?
- ☐ Can it provide multiple custom permission bundles for different types of users?
- ☐ Does it allow you to immediately deploy new locations or user experiences?
- ☐ Can it recognize repeat visitors and track document signature status and expiry dates?
- ☐ Does it recognize repeat visitors across different locations and auto-fill details, recognizing previously signed documents?



Customization

- ☐ Can the solution provide custom workflows and user-specified triggers?
- ☐ Does it provide custom branding for locations, subsidiaries, and location types?
- ☐ Can you enable different languages for different locations or users?
- ☐ Does it allow visitors to be classified into different user types?
- ☐ Does it include management of processes beyond the lobby (eg. guard gates, parking, preregistration)?
- ☐ Does it allow for custom badge layouts, variety of badge materials, and expiry mechanisms?
- ☐ Does it allow for signature of multiple document types?
- ☐ Can you remove all vendor branding and advertising?



Security

- ☐ Does the solution provider have enterprise security certifications, such as SOC2?
- ☐ Is platform deployment be available in regional data centers?
- ☐ Does it have local data residency options?
- ☐ Is there a single tenant deployment option?
- ☐ Can centralized global watchlists be managed across different locations?
- ☐ Does the watchlist feature allow for at minimum 3 custom list definitions and uniquely configured workflows?
- ☐ Can it provide government ID and passport validation by enterprise-grade scanners?
- ☐ Does it comply with all US and international privacy regulations, such as GDPR?
- ☐ Does it comply with applicable industry regulations (ITAR, PCI, FISMA, GMP etc.)?
- ☐ Does it provide a real time view of who is on site at any given time?



Integration

- ☐ Does the solution provide integrations with Single Sign On technologies such as SAML 2.0, Active Directory, etc.?
- ☐ Does it enable integrations with business productivity platforms (Google suite, Outlook, Slack, etc.)?
- ☐ Is it possible to enable custom integrations via Rest API?
